

Trolley Dash Competition:

Competition Rules:

1. This event is organized by City Property Administration (Pty) Ltd ("the organizers") and as such, is subject to the standard terms and conditions relating to competitions that can be found on our website at www.cityproperty.co.za.
2. The Competition will run from the **5 July 2021** to the 6 August 2021 at Waverley Plaza Shopping Centre.
3. **The prize will consist of a trolley dash worth R 5000 at Pick n' Pay Waverley Plaza Shopping Centre.**
4. The following persons are not eligible to participate in the campaign: any employee or director of the Landlord and/or the organiser, any tenant of the Landlord whose account is in arrears at the date of the draw, immediate family members of any employee or director of the Landlord and/or the organiser.
5. The winner(s) will be determined by a lucky draw done by a nominated independent person to the competition.
6. Entry forms to the competition are available at retail shops located at Waverley Plaza shopping centre, 1116 Hertzog Street Villieria Waverley Pretoria.
7. In order to enter the competition, you must spend R 300 or more collectively at any of the participating vendors, attach your original purchase slips to the entry form, and place your entry form in the competition boxes provided.
8. In the event that the original purchase slips needs to be retained, the duplicate slip can be presented but must be authorised by a nominated representative.

10. Ineligible, incomplete or altered entry forms will not be considered and is automatically void.
11. Participants must reside in Gauteng in order to be considered for the prize.
12. Participants are allowed to enter as many times as they wish, but only one prize per person will be awarded.

14. The lucky draw will take place on **14 August 2021 10:00** at Waverley Plaza Shopping Centre.
